### 1. IBPSA BOARD OF DIRECTORS ELECTION 2023

### 2. INTERNATIONAL BUILDING PERFORMANCE SIMULATION ASSOCIATION (IBPSA) AGM

While in normal circumstances every 2 years the AGM of IBPSA would occur during the Building Simulation Conference, this year, the 2023 AGM and Board meeting will be held online on 27 October 2023 as per the notice below. The Board considers a hybrid meeting as the only fair and possible solution for the 2023 AGM to ensure that all IBPSA members from around the world will be able to participate in the meeting.

\* Click the box next to the candidate's name

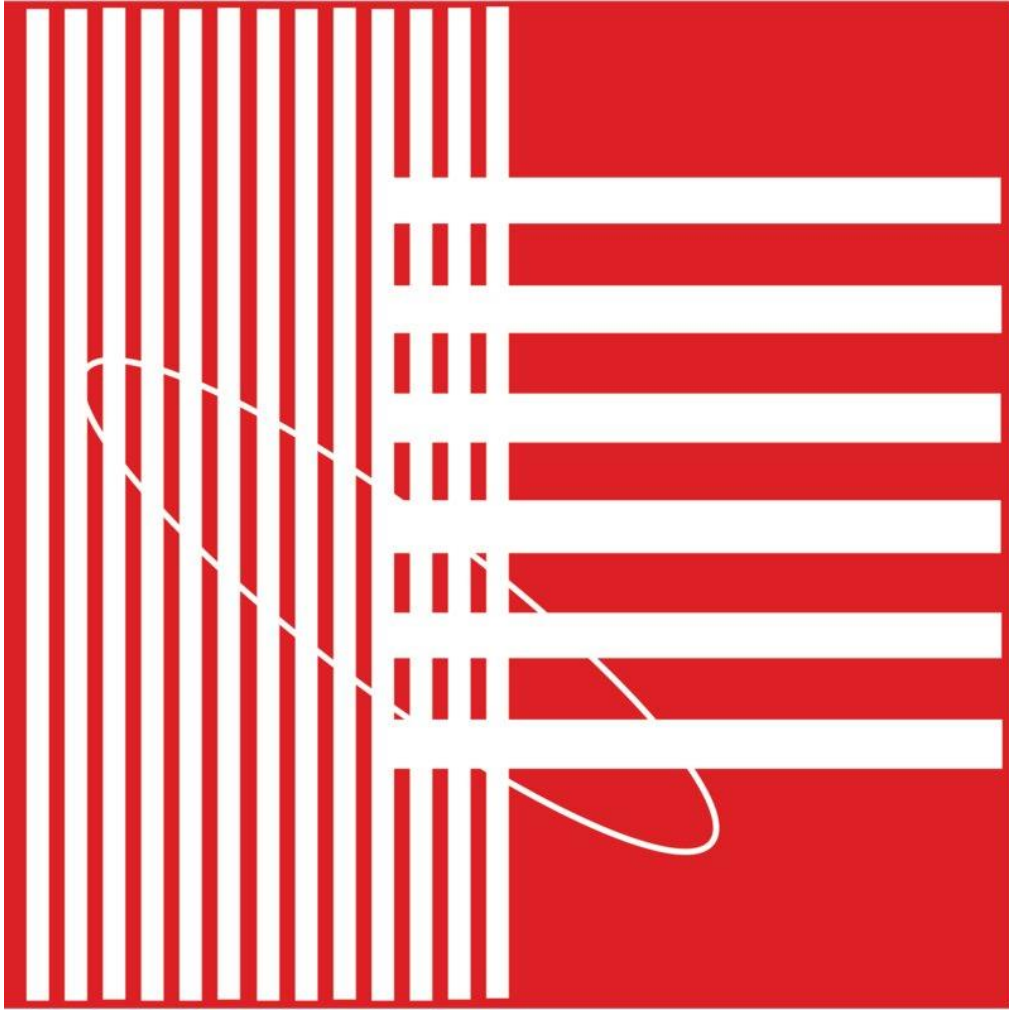
\* To change your vote, click the box again to remove the mark
