- Discuss, confirm and validate the planning concepts and especially the updated Long-term Vision (Section 4.2).

When you read the report, please focus on the above mentioned points especially related to the specific sector of your organization. Also, we are still expecting to improve our understanding of Erbil situation, we are waiting for your active participation in giving us comments on the PGR1 and share with us the most appropriate and up-to-date data and information to improve it.
