



## Assertion.

**Definition**: a claim or statement that needs to be proven or explained

#### **ASSERTION**

Children enjoy learning at academies.

#### Reason.

O Definition: The act of proving an assertion by explaining. describing. and elaborating

#### **REASON**

Academies have a positive effect on their education

## Evidence

- Definition: facts, information, or observations presented in support of an assertion.
  - Studies show that playing video games causes children to become more violent in personality.

#### **EVIDENCE**

A study from Seoul National University in 2007 said that 69% of children were satisfied with their private school classes. Additionally, 73.9% of children also thought that academies had a positive effect on their public school grades and abilities

Pro Argument #1

A: Children enjoy learning at academies

R: Academies have a positive effect on their education



## Conclusion


- Argument: A+R+E+I

  - Strong logic and reasoning
  - Evidence that is supportive
  - Explain the importance of your argument



## What is a Refutation

A refutation is an attack against the other team's argument.





## What is a Rebuttal?

- A rebuttal is a defense against the refutation
  - · The rebuttal should rebuild your teammate's orginal argument

## What is a Rebuttal?

- 1. Identify the other team's argument
  - Their argument was...
- 2. State the counter-argument
  - However, my refutation to this is...
- 3. Provide reasons for the counter-argument
  - · Explain why you disagree with the other team's argument
- 4. Show why the counter-argument is more important than the other team's argument
  - Therefore...

## Structure

There are 4 steps to making a rebuttal

#### matter, method and manner

Adjudicators asses your speech according to three criteria:

matter, method and manner. Matter refers to your arguments. A good way to think about matter is to consider how you write essays, like text responses. An essay, like a speech, has an introduction, a body, and a conclusion.

refers to the content in the speech.

Speeches should be as original as possible. Each speech should have a key argument or point of view. Speeches must be of a persuasive nature and not simply sequential information about a topic.

Matter refers to your arguments. A good way to think about matter is to consider how you write essays, like text responses. An essay, like a speech, has an introduction, a body, and a conclusion.

Method ریکا وبیکهاته وکات is the structure and timing of your speech. It also considers team method.

Internal Method is the way your own speech is structured. Every speech should have a recognisable beginning (introduction), middle and end (conclusion).

is the way in which you deliver your speech.

It is the most subjective aspect of debating, the only rule of which is that you must be persuasive. As a speaker, you have to develop a style that works well for you, so that the audience views you as a persuasive speaker.
